# **Minutes of Tomsett Elementary School PAC**

## February 20, 2020

### **In Attendance**

PAC Members: CM, CL, FD, LB, ST, MC, HK

#### Call to order

The meeting was called to order at 18:33 pm CM and LB.

#### **Principal's Report**

- 1. Playground removal complete we wanted to be sure that the community was aware that it was coming out, as we have other schools in the past where workers showed up to remove it (and did so) without anyone knowing.
- 2. Working with the City had a meeting on Tuesday to discuss having the sidewalk extended on the north side of Odlin from where it ends before the two houses to connect up with our school lot. This will be done shortly. City is also going to do a traffic study to determine the location of a new crosswalk to the west as we now have children walking and approaching from both directions on Odlin.
  - a. Spoke with Bill Dhaliwal
  - b. Maybe raising the current crossing a little, so drivers will have to slow down more.
- 3. Krispy Kreme Fundraiser **blank** orders.
  - a. 120 orders
- 4. EDI Early Development Instrument for Kindergarten completed. This is data collected by teachers that helps to create a report that is used by many levels of government when determining kids who are at risk, what programs or services should see additional funding, etc.
  - a. All schools in lower mainland Access to data will be available next year
    - i. Provide holes in the study so we can patch any holes.
  - b. MDI Middle years inventory
- 5. Breakfast Club update our Breakfast Club continues to be a success. Thank you to our staff who are making this happen (Mr. Burns, Ms. Ferreira, and out E.A's). We are feeing approx. 40\_children and with the changes to the parking lot, having the open gym component has taken pressure off the parking lot.
  - a. Feeding about 40 kids, could be up to about 50 kids closer to 8.30am.
- 6. Construction out date for construction (preload) continues to get pushed back. We are looking at early March before construction will begin. Much like notifying our community about our playground removal, we purposely closed the side parking lot and changed the parking lot structure to give our community lots

of time to get used to and for staff to figure out, how best to make this happen. You can imagine the chaos and anger that would have occurred had we changed things overnight.

- a. 1st week of march for fencing to go up
- b. Blacktop to be removed and pre-load have to sit for a while.
- c. Continue to look for solutions about parking lots. Hard part is end of day pick-ups.
- d. Staff have been good in helping out with end of day pickups which really helps elevate the traffic.
- 7. Report Cards will be sent home on Friday, March 13<sup>th</sup> traditional reports. Report cards for our ePortfolio students were sent home at the end of January.
  - a. Traditional reports March 13, 2020.
- 8. Questions?
  - a. Construction pushed to March when playground expected?
  - b. Heavy equipment to be maneuvered around the playground site
  - c. Funds for playground to be obtained.
  - d. What can kids do during lunch time? Lego club, knitting club, art class, soccer. Providing options to kids. Outdoor games which will be taught during PE class which kids can also play outside during lunch time.
  - e. KM run? not sure if this will be happening this year. No circuit
  - f. After school pickup walkie talkie between teachers to prep kids to be picked up.

## **PAC Co-Chair's Report**

- 1. Playground Fund
  - a. PAC sent newsletter to families in February.
  - b. Mike will ask Ning if its possible to set up playground fund online so parents can donate via Credit Card payments.
  - c. Our playground is on School District land.
- 2. Fundraising Report
  - a. Family Photo Night Kirsten Laufer (photographer) has completed all photo editing and have emailed galleries to families.
    - i. Generated approx. \$200.00
    - ii. October for Christmas cards
  - b. Krispy Kreme Fundraising forms received and will be counted if not already; Big thank-you to SC and MC for assisting with the counting, ordering and pick-up.
    - i. Kids will be able to pick up on 27th.
  - c. Clothes for Cash with Big Brothers scheduled to begin collection after Spring Break. CL will arrange a pickup time with Big Brothers.
    - i. Starting March 30 to April 6 for donations.
    - ii. Bags to be used is the large black bags.
    - iii. A minimum of 150 bags at least
    - iv. Flyers will go home at a later
- 3. New Hot Lunch Program now accepting orders.
  - a. All orders will be done online, no cash or paper forms will be accepted.
  - b. Families need to set up a Munch-a-Lunch account to order hot lunch for their child.
  - c. Menu also shows Chinese translation.

- d. PAC Secretary to confirm with Fuel: 50 minimum orders? Possibility of swapping out sushi for other vendor.
- 4. City of Richmond Neighborhood Celebration Grant Application deadline March 8, 2020
  - a. PAC applied last year and was granted a generous amount that was used towards our Year End Party in June 2019.

    - iv. Tentative Date for YE party: June 20, 2020
